

ORDINANCE No. 148984

An Ordinance abolishing one position of Affirmative Action Investigator and creating one position of Affirmative Action Analyst in the Bureau of Personnel Services, Affirmative Action Unit, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The duties and responsibilities of the position of Affirmative Action Investigator in the Bureau of Personnel Services, Affirmative Action Unit, have been reviewed by the Bureau of Personnel Services.
2. That it has been recommended by the Bureau of Personnel Services and approved by the Civil Service Board that the duties and responsibilities pertaining to said position are more appropriate to the classification of Affirmative Action Analyst.
3. The necessary additional resources for FY 1979-80 will be provided by salary savings within the Bureau's appropriations.

NOW, THEREFORE, the Council directs:

- a. The following position is created in the Bureau of Personnel Services, Affirmative Action Unit, with a salary rate in accordance with the current Compensation Plan:


- b. The following position in this Bureau is abolished:

The Council declares that an emergency exists because the position to be created is immediately required in order that the new functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, the Ordinance shall be in force and effect from and after its passage by the Council.
