ORDINANCE No. 148989

An Ordinance creating and abolishing various positions within the Bureau of Water Works, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The positions of Accounting Assistant, Associate Accountant and Clerk II are required in lieu of the positions of Clerk III, Water Appropriations Ledger Clerk and Typist Clerk.
- 2. The position reclassifications are more consistent with the actual duties of the positions.
- 3. The Bureau of Personnel Services has reviewed and approved the action.

NOW, THEREFORE, the Council directs:

a. The following positions are created in the Bureau of Water Works with salary rates in accordance with the current compensation plan:
