# ORDINANCE No. 149012

An Ordinance creating one position of Water Service Mechanic in the Bureau of Water Works, transferring funds and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. One position of Water Service Mechanic (Class 1720) is required by the Bureau of Water Works, Operations Division.
- 2. Work activity in the Operations Division and in the noted classification has increased such that an added position is now necessary.
- The necessary additional appropriations should be provided by a transfer of funds from the Bureau of Water Works, Contingency Fund, to the Bureau of Water Works, Water Fund.
- 4. The change has been approved by the Bureau of Personnel.

# NOW, THEREFORE, the Council directs:

- a. One position of Water Service Mechanic (Class 1720) in the Bureau of Water Works is hereby established.
- b. Hourly rate for the new position shall be in accord with the current compensation plan.
- c. \$12.800 to support the salary and benefits of the new position is transferred from the Bureau of Water Works, Contingency Fund BUC 17500155, Object Code 710 to the Bureau of Water Works, Water Fund, BUC 18400359, Object Code 110.

Section 2. The Council declares that an emergency exists as the position created in Section 1 is vital to carry out the business of the Bureau and should be accomplished without unnecessary delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
