ORDINANCE No. 149025

An Ordinance adjusting the rate of pay for certain classifications, amending the Compensation Plan, and declaring an emergency.

Section 1. The Council finds:

- 1. That some classifications have entry rates below the new federal minimum wage and should be adjusted accordingly.
- 2. That new rates should be established effective January 1, 1980 and the Compensation Plan amended.
