## ORDINANCE NO. 149026

An ordinance transferring \$17,600 in appropriation within the Housing and Community Development and General Funds for six specific projects in the Bureau of Parks; and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. That six projects in the Bureau of Parks have been approved for Housing and Community Development funding.
- 2. That additional appropriation of \$17,600 is needed in the Bureau of Parks to successfully implement these projects.
- 3. That the additional \$17,600 appropriation will be used on the following projects: lighting in Woodlawn Park (\$4,000); basket-ball court and lighting in Trenton Park (\$5,000); play equipment for Lair Hill Park (\$500); redesign 18th and Holman (\$3,100): basketball court in North Park Blocks (\$2,000); and Pioneer Church brick walkway (\$3,000).
- 4. That no additional resources will be needed from contingency to fund these six projects.
- 5. That the additional appropriation should be provided by transfer from the Housing and Community Development Fund.

NOW, THEREFORE, The Council directs:

a. That the 1979-80 City budget is hereby amended as follows:
