ORDINANCE No. 149029

An Ordinance authorizing Change Order #3 in an amount not to exceed \$109,457.87 for the Access Road and Cofferdam for the Hydroelectric Power Project, authorizing a time extension of 60 days, authorizing the transfer of funds, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That additional work is necessary to support and stabilize half-round drainage pipe, install a grounding bed under the access road, install water control pond #3 and provide consolidation grouting along the existing spillway at Dam No. 1.
- 2. That an additional appropriation of \$109,457.87 is needed for this work.
- 3. That a time extension of sixty days is needed for this work.
- 4. That Change Order #3 in an amount not to exceed \$109,457.87 is needed to Contract #18005 with Willamette-Western Corporation to complete this work.
- 5. That a fund transfer within the Hydropower Construction Fund of \$109,457.87 is required.

NOW, THEREFORE, the Council directs:

- a. That Change Order #3 in an amount not to exceed \$109,457.87 to Contract #18005, Willamette-Western Corporation be authorized.
- b. That a time extension of sixty days to Contract #18005, Willamette-Western Corporation be authorized.
- c. \$109,457.87 is transferred within the Hydropower Construction Fund #28 from BUC 64000012 (Hydropower Contingency), Expense Code 710 to BUC 64200003 (Hydropower Construction), Expense Code 630 (Improvements).

Section 2. The Council declares that an emergency exists because a delay in proceeding with the project would result in an increased project cost to the City; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
