# ORDINANCE NO. 149049

An Ordinance authorizing the transfer of \$20,100 within the General Fund from the Bureau of Police to Transfers to Other Funds - Electronic Services Fund and increasing the appropriations of the Electronic Services Fund, Bureau of Electronic Services by \$20,100 for the purchase of video equipment and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. That the Bureau of Police requires video surveillance equipment for use by the Fence Interdiction Project.
- 2. That the funds needed for the purchase of said equipment may be obtained by transfer of monies appropriated in the FY 1979-80 budget for the Bureau of Police, Fence Interdiction Project.
- 3. That appropriations should more appropriately be transferred to the Bureau of Electronic Services for the coordination and purchase of said equipment.

#### NOW, THEREFORE, the Council directs:

a. Appropriations of \$20,100 are hereby transferred within the General Fund as follows:
