An Ordinance transferring \$80,675 within the General Fund from General Operating Contingencies \$33,175) and Unforeseen Reimbursable Expenditures (\$50,500) to the Office of Cable Communications; creating one position of Cable Communications Director; setting salary rates; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- One position of Director and supporting funding is 1. required by the Office of Cable Communications, in order to carry out the functions assigned to the office.


