AGREEMENT AMENDING CONTRACT #17/849

This agreement is entered into between the City of Portland, Oregon and the Northwest Regional Educational Laboratory (NWREL). The parties have previously executed Contract #17849 by which the Human Resources Bureau will receive up to \$80,000 to be used for supportive services for young women involved in the Women in Non-traditional Careers (WINC) program.

This contract was for the period May 11, 1978 through February 15, 1980. The parties now agree to extend the contract for the period from February 16, 1980 through September 30, 1980.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to Ordinance No. 147500, as amended by Ordinance No. 147993, the City of Portland entered into Contract No. 17849 with the Northwest Regional Educational Laboratory (NWREL), by which the City would receive up to \$80,000 for the payment of support services for young women involved in the Women in Non-traditional Careers (WINC) program for the period May 11, 1978 to February 15, 1980.
- 2. The Human Resources Bureau and NWREL have now agreed to extend the expiration date of Contract No. 17849 from February 15, 1980 to September 30, 1980.
- 3. It is therefore appropriate that the Mayor and the Commissioner of Public Utilities execute, on behalf of the City, an amendment to Contract No. 17849, as set forth in Exhibit "A".

NOW, THEREFORE, the Council directs:

a. That the Mayor and the Commissioner of Public Utilities are hereby authorized to execute, on behalf of the City, an amendment to Contract No. 17849 with the Northwest Regional Educational Laboratory, as set out in Exhibit "A".

Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance will result in hardship for WINC project participants; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
