## ORDINANCE No. 149199

An Ordinance abolishing one position of Police Officer and creating two positions of Police Records Clerk I in the Bureau of Police, Records Division and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the duties and responsibilities of the personnel in the Records Division of the Bureau of Police have been reviewed by the Bureau.
- 2. That the specific duties performed by the position of Police Officer, which is presently vacant, have been shifted to supervisory personnel within the Records Division.
- 3. That supervisory personnel now spend a great amount of time performing operational level (non-supervisory) functions.
- 4. That the requested Police Records Clerk I positions will free the supervisors from these operational tasks and will allow them to perform their supervisory functions plus absorb the duties of the Police Officer.
- 5. That the FY 80-81 budget request submitted by the Police Bureau requests that the position of Police Officer be abolished and the two (2) positions of Police Records Clerk I be created.
- 6. That the necessary additional resources required for FY 79-80 will be provided by salary savings within the Bureau's appropriations.
- 7. That the appropriate classifications should therefore be made.

NOW, THEREFORE, the Council directs:

a. One (1) position of Police Officer (5128) is hereby abolished and two (2) positions of Police Records Clerk I (0150) are hereby created with salary rates in accordance with the current Compensation Plan in the Bureau of Police, Records Division.

Section 2. The Council declares that an emergency exists because the positions to be created are immediately required in order that the new functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
