ORDINANCE No. 149241

An Ordinance transferring appropriation in the amount of \$1,056 within the General Fund from General Operating Contingencies to the Sister City Program, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Appropriation for the Sister City Program for the 1979-80 fiscal year will be insufficient to cover all anticipated expenditures through June 30, 1980.
- 2. Cancellation of an outstanding purchase order for the Sister City Program from the prior year will create savings of \$1,056 which cannot be used in the current year without a transfer of appropriation.
- 3. It is in the best interest of the City to provide for expenditures in the Sister City Program to June 30, 1980, by a transfer of \$1,056 from General Operating Contingencies.

NOW, THEREFORE, the Council directs:

a. Appropriation in the amount of \$1,056 is hereby transferred within the General Fund as follows:

From: General Operating Contingencies (20100010) \$1,056.

To: Sister City Program (40500014) \$1,056

Section 2. The Council declares that an emergency exists as there should be no unnecessary delay in providing appropriation for the Sister City Program to June 30, 1980; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
