# ORDINANCE NO. 149211

An Ordinance authorizing the transfer of \$954 within the General Fund from Operating Contingency to Transfers to Other Funds - Electronic Services and increasing the appropriations of the Electronic Services Fund, Bureau of Electronic Services by \$954 for the purchase of a cable television modulator and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. That the Bureau of Police requires the ability to send video transmissions between precincts.
- 2. That the purchase of a cable television modulator is essential to effect the video transmissions.
- 3. That the cable television modulator be purchased by the Bureau of Electronic Services and subsequently rented by the Police Bureau.
- 4. That the additional appropriation necessary to acquire the required modulator should be provided by transfer from Operating Contingency to the Bureau of Electronic Services.
