ORDINANCE No. 149263

An Ordinance amending Ordinance No. 148347, being an Ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses, for the one-month billing period ended May 31, 1979, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 148347 assessed Tax Lot 2, of Lots 14 16, Block 15, Multnomah, \$126.00 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended May 31, 1979, and entered in the City Lien Docket Book 124, Page 59.
- 2. Part of the work charged for was done on adjacent property.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 148347 is amended by reducing the assessment against Tax Lot 2 of Lots 14 16, Block 15, Multnomah, by \$63.00 and reducing the total assessment of \$3,343.41 to \$3,280.41.
- Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
