ORDINANCE NO. 149270

An Ordinance amending Ordinance No. 148923 to increase allowable payments to Dale R. Brunton for negotiating services required for acquisition of easements for the SW Arnold Creek Sanitary Sewer System to a total not to exceed \$8,000.00, and to clarify the method for paying for such services, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance 148923 authorized the City Engineer to obtain the services of Dale R. Brunton to provide negotiation services for acquisition of easements for the SW Arnold Creek Sanitary Sewer System, with the provision that total payments for such services would not exceed \$3,000.00, and further that such payments would be chargeable to General Fund (Buc No. 43300016/490) Appropriations, Contributions and Advancements to Improvement Districts (SW Arnold Creek Sanitary Sewer System). However, said Ordinance failed to provide reimbursement to the General Fund from the SW Arnold Creek Sanitary Sewer System Fund, when created.
- 2. That Mr. Brunton has shown himself to be an effective negotiator, and so in order to complete the acquisition of easements in a timely and orderly manner, the City Engineer recommends additional payments in the amount of \$5,000.00 for negotiating services now be authorized (total payments not to exceed \$8,000.00), and that provisions for reimbursement of the General Fund should now be made.

NOW, THEREFORE, the Council directs:

- a. Section 1, paragraph b of Ordinance 148923 is amended to read as follows:
 - "b. Payment for Mr. Brunton's services shall be at the rate of \$175.00 per eight hour day (\$21.875 per hour), said payment to cover negotiator's time and all automobile, travel and other expenses incurred in connection with calls on property owners or other interested parties within twenty miles of the project area. All necessary maps, legal documents and other supporting material will be supplied to the negotiator by the City Engineer's office. The total sum of such payments shall not exceed \$8,000.00."
- b. Section 1, paragraph c of Ordinance 148923 is amended to read as follows:
 - "c. The Mayor and Auditor are authorized to draw and deliver warrants in favor of Dale R. Brunton, chargeable to General Fund (Buc No. 43300016/490) Appropriations, Contributions and Advancements to Improvement Districts (SW Arnold Creek Sanitary Sewer System) in payment for negotiation services. Payment in those amounts approved by the City Engineer shall be made on or before the 15th day of the month following the month of billing. The Mayor and Auditor are

further authorized to draw warrants in those amounts approved by the City Engineer to be credited to General Fund Revenue, said warrants to be drawn against and chargeable to the SW Arnold Creek Sanitary Sewer System Fund, when created.

c. All other conditions of said Ordinance No. 148923 shall remain in force and effect.

Section 2. The Council declares an emergency exists, because a delay in passage of this ordinance would interrupt orderly acquisition of easements for a sewer project now under contract; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
