WHEREAS, the Portland General Electric Co., c/o J. S. Volpe, 621 S.W. Alder St., Portland 5, Oregon, has made application and submitted plans as required by the Public Works Code for a revocable permit to enlarge an existing hand hole in the east side of S.W. 6th Avenue approximately 10 feet south of the south line of S.W. Morrison Street to 5 feet in width by 10 feet in length, and

WHEREAS, the City Engineer has approved the plan for the enlargement of the said hand hole, therefore,

Exhibit "A" is hereby adopted as the official plan for the enlargement of the said hand hole,

BE IT FURTHER RESOLVED that a revocable permit is hereby granted to the Fortland General Electric Company (hereinafter referred to as the grantee) to enlarge a hand hole now in the street area on the east side of S.W. 6th Avenue approximately 10 feet south of the south line of S.W. Morrison Street to a width of 5 feet and a length of 10 feet inside measurement, in accordance with the plans and specifications for such structures and the attached plan marked Exhibit "A" approved by the City Engineer under date of June 6, 1947, and made a part of this resolution, and to maintain the said enlarged hand hole, said revocable permit being granted under the following conditions:

- l. That the grantee shall assume full responsibility for any accidents or damage which may occur during the construction of the said hand hole and shall hold the City of Portland, the City Engineer, and each and all of the officers and employes of said City free and harmless from any claims for damages to persons or property which may be occasioned by any construction and/or maintenance carried on under the permit hereby granted.
- 2. This permit is revocable at any time at the pleasure of the Council, and no expenditure of money hereunder, or lapse of time, or other act or thing shall operate as an estoppel against the City of Portland, or be held to give the grantee any vested or other right. Within thirty (30) days from the revocation of this permit, the grantee shall remove the said hand hole from the street area as required by and to the satisfaction of the City Engineer.

- 5. This permit is for the use of the street area only, and shall not exempt the grantee from taking out a permit from the city Engineer for opening the street or from taking out licenses or permits required by any existing ordinances for any operation or construction carried on under the permit hereby granted.
- 4. That a fee of \$10.00 as provided by paragraph (b), Section 5-403 of the Public Works Code be paid to the City Treasurer within ten (10) days from the date hereof.
- 5. Within ten (10) days from the date hereof, the grantee shall file with the City Auditor a document satisfactory to the City Attorney accepting the terms and conditions hereof.
