When websites are built they are automatically optimized for mobile, that optimization often results in a rescaling of sections and text, which is precisely what happened here. We have re-coded the mobile site and increased the size of the disclaimer language.

Counter to the complainants opinion there was no intent to reduce or hide the disclaimer information. The disclaimer was and is accurate and fully visible on any device.
