An Ordinance amending Ordinance No. 148714, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended July 31, 1979, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 148714 assessed Camerons Add. Block 3, Lot 8, \$157.50 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended July 31, 1979, and entered in the City Lien Docket Book 124, Page 91.
- 2. The amount to be charged for the work done was incorrectly computed and should have been \$144.90.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 148714 is amended by reducing the assessment against Camerons Add., Block 3, Lot 8, by \$12.60 and reducing the total assessment of \$4,784.85 to \$4,771.95.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
