ORDINANCE NO. 149450

An Ordinance abolishing one position of Human Resources Specialist IV(7458); creating one position of Human Resources Coordinator II; and authorizing the appointment of Al Jamison as Human Resources Coordinator II at the one year rate in the Office of Public Safety, Residential Care Facilities, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The duties and responsibilities of Human Resources Specialist IV have been reviewed by the Bureau of Personnel Services.
- 2. That it has been recommended by the Bureau of Personnel Services and approved by the Civil Service Board that the duties and responsibilities pertaining to said position are more appropriate to the classification of Human Resources Coordinator II.
- 3. Al Jamison is currently employed as a Human Resources Specialist IV in the Office of Public Safety, Residential Care Facilities, and has the prior experience and training to warrant appointment as a Human Resources Coordinator II, at other than the entry rate.
- 4. The necessary additional resources for FY79-80 will be provided by salary savings within the Bureau's appropriations.
- 5. The appropriate classification should therefore be made, effective February 19, 1980.
- 6. That Al Jamison is eligible for pay at the "after **two**-year" rate on February 19, 1980.

NOW, THEREFORE, the Council directs:

a. The following position is created, effective February 19, 1980 in the Office of Public Safety with a salary rate in accordance with the current Compensation Plan:

c. That Al Jamison is hereby appointed as Human Resources Coordinator II in the Office of Public Safety, Residential Care Facilities, at the "after one-year" rate, effective February 19, 1980.

The Council declares that an emergency exists because the position to be created and filled by the appointment of Al Jamison is immediately required in order that the new functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
