An Ordinance designating portions of the City-State-owned property east of and adjacent to the east curb line of Front Avenue to be used by the KGW Broadcasting Company to hold their annual Neighborfaire carnival and exhibition, as a City park governed by the requirements, regulations, and prohibitions of City Code Chapters 20.04, 20.08 and 20.12, certain exceptions, for the effective date of the Ordinance, from 6:00 a.m., to 12:00 Midnight on July 13, 1980, and in case of inclement weather, on July 20, 1980, under certain conditions and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City has issued to KGW Broadcasting Company a revocable permit to use portions of the City-State-owned property east of and adjacent to the east curb line of Front Avenue to hold their annual Neighborfaire carnival and exhibition from 6:00 a.m., to 12:00 Midnight on July 13, 1980, and in case of inclement weather, on July 20, 1980.
- 2. It is in the interest of the public health, safety and welfare that the area covered by the revocable permit be designed as a City park governed by the requirements, regulations, and provisions of City Code Chapter 20.04, 20.08 and 20.12, subject to certain exceptions, during the term of the permit.
- 3. The designation of the area covered by the revocable permit as a City park should not prevent KGW Broadcasting Company from carrying on those activities authorized by the permit.

NOW, THEREFORE, the Council directs:

a. For the effective date of this Ordinance, July 13, 1980, the following area shall be a City park called Waterfront Park subject to the provisions of City Code Chapters 20.04, 20.08 and 20.12, except that the area for this period shall not be subject to the City Code Section 20.12.040:

The area whose boundaries generally are described as the Willamotte River seawall, the north curb line of S.W. Jefferson Street extended the east curb line of Front Avenue, and the south curb line of N.W. Glisan extended.

b. It is unlawful for any person to take into or upon the area, described in subsection "a" of this Ordinance, any alcoholic beverages during the time the area is designated as a City park under this Ordinance. Violation of this provision shall be subject to the provisions of City Code Section 14.08.020. Further, for the effective date of this Ordinance, from 6:00 a.m., to 12:00 Midnight on July 13, 1980, the provisions of City Code Section 20.12.040 are amended to allow the consumption of beer and/or wine in the park area, provided that such beverages were purchased from persons to whom a permit for the sale of such alcoholic beverages has been issued.

- c. Nothing in this Ordinance shall prevent KGW Broadcasting Company from carrying on those activities authorized by the revocable permit issued to it by the City. The revocable permit shall be deemed to satisfy all permit requirements contained in City Code Chapters 20.04, 20.08 and 20.12, for those activities authorized by the revocable permit.
- d. Permittee hereby agrees to be responsible for all damages to City property excepting normal wear and tear and also to bear all cost for services required or provided by City in conjunction with this event.
- e. Permittee agrees to make payment within 30 days of billing by City to permittee.

Section 2. The Council declares that an emergency exists because delay in the enactment of this Ordinance will limit the ability of the City to protect the public health, safety, and welfare during the term of the revocable permit; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
