# ORDINANCE NO. 149482

An Ordinance accepting an Oregon Arts Commission grant in the amount of \$1,500 to be used for the Metropolitan Arts Commission's quarterly arts calendar, authorizing a contract, increasing appropriations of the Federal Grants and General Funds and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. The Metropolitan Arts Commission is producing a quarterly Arts events calendar.
- 2. The Oregon Arts Commission has established a Challenge Grant Program for community arts councils and these funds have been awarded to the Metropolitan Arts Commission in the amount of \$1,500 for the production of a quarterly arts events calendar.
- 3. Matching funds for this Oregon Arts Commission grant are provided in the 1979-80 Metropolitan Arts Commission budget.
- 4. It is therefore appropriate that the Mayor be authorized to accept funds for said purpose and that appropriations be increased for this fiscal year.

## NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute a grant agreement.
- b. The Mayor is hereby authorized to accept on behalf of the City, an Oregon Arts Commission grant to be used for the Metropolitan Arts Commission's quarterly arts calendar, in the amount of \$1,500.
- c. The 1979-80 City Budget is hereby amended to include increases in appropriations as follows:
