ORDINANCE No. 149524

An Ordinance transferring \$17,240 within the General Fund from Operating Contingency to the Bureau of Police, Criminalistics Division, for the purchase of photographic supplies and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Police requires certain photographic supplies for the operation of the Criminalistics Division for FY 1980-81.
- 2. That the Bureau of Police has been advised by the supplier of said supplies of a 38% price increase to be effective May 15, 1980.
- 3. That the cost of supplies needed for FY 1980-81 would amount to \$17,240 if purchased before May 15, 1980 and would cost \$23,791 thereafter.
- 4. That the Bureau of Police has requested resources in the amount of \$20,000 for this purpose in its FY 1980-81 budget request.
- 5. That if the said supplies were purchased prior to May 15, 1980, the FY 1980-81 budget for the Bureau of Police could be reduced by \$20,000 and in addition, this purchase would reflect a savings of \$6,551 to the City.
- 6. That the additional appropriation should be provided by transfer from Operating Contingency.

NOW, THEREFORE, the Council directs:

- a. \$17,240 is transferred within the General Fund from Operating Contingency (20100010) to the Bureau of Police, Criminalistics Division (11800017. 320, Project 0400).
- Section 2. The Council declares that an emergency exists because the appropriation is needed immediately in the account to which it is to be transferred because a delay in proceeding with the purchase may result in additional expenses; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
