ORDINANCE NO. 149525 .

An Ordinance authorizing the Purchasing Agent to call for bids for the project "Portland City Hall Mechanical Improvements", using revised specifications which reduce the scope of the project, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That, pursuant to Ordinance #147565, the Purchasing Agent called for bids for the construction of a certain improvement to the HVAC system of the first floor of City Hall and to the Council Chambers.
- That on May 31, 1979 two responsive bids were received. The low bid exceeded the amount available and previously authorized by the Council by \$190,710.00.
- 3. That the consulting mechanical engineer has recommended that the scope of the project be reduced by deleting the Council Chamber improvements and by deleting all fan-coil air conditioning units currently in the project. These reductions should enable the City to receive a bid within the project budget.
- 4. That the project should be rebid using revised specifications which reduce the scope of the project as mentioned above.
- 5. That the rebid will result in bids being received in the 1979-80 fiscal year.
- 6. That the funds for this project, \$160,500.00 are currently within the 1979-80 Fiscal Year Budget of the Bureau of Facilities Management and that the project should be rebid.



ORDINANCE No.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using revised specifications in his office and in the event no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Commissioner of Public Utilities and Auditor hereby are authorized to draw and deliver warrants chargeable to the 1979-80 budget of the Bureau of Facilities Management (BUC 34900141/630) when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay will deprive the City of the benefits of an early completion of the project and is likely to increase total project costs; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
