ORDINANCE NO. 149535

An Ordinance authorizing payment to Pacific Marine Diving Company, Inc., 2000 E. Columbia Way, Bldg. #56, Vancouver, Washington 98661 for diving services required for repairs on the South Tower at Dam #2 for the Bureau of Water Works in the amount of \$14,160.00, waiving informal competitive solicitation of bids and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That diving services were necessary to perform repair work on South Tower at Dam #2.
- 2. That Pacific Marine Diving Company was already at the site working on another project and was familiar with the work and conditions, and it was necessary for the repair work to be performed immediately; therefore, it was not practical to obtain informal competitive solicitations of bid to perform the work.
- That said action was approved by the Commissioner-in-Charge.
- 4. That due to the adverse working conditions, an additional diver was needed to perform the work; therefore, purchase Order #9886 for \$9600.00 was exceeded by \$4,560.00, for a total cost of \$14,160.00.

NOW THEREFORE, the Council directs:

- a. That informal competitive solicitations of bids is waived for diving services required for repairs of the South Tower at Dam No. 2 for the Bureau of Water Works.
- b. That payment to Pacific Marine Diving Company, Inc., 2000 E. Columbia Way, Bldg. #56, Vancouver, Washington 98661 for diving services is authorized and shall be chargeable to the 1979-80 Water Bureau Budget, BUC 18520061, Object Code 260, Project 1104 (Dam #2 O & M) when demand is presented, approved by the proper authorities.

ORDINANCE No.

Section 2. The council declares that an emergency exists to maintain the city water supply facilities in an operable condition; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
