### ORDINANCE NO. 149541

An Ordinance transferring appropriations within the Housing and Community Development and General Funds; increasing appropriations in the Bureau of Economic Development in the amount of \$50,000 for the preparation and execution of a special business assistance program for the Powell Boulevard Phase II Street Improvements Project; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Powell Boulevard Phase II Street Improvements Project, approved by the Council in Resolution No. 32360, will cause displacement of over 30 in-City businesses.
- 2. Businesses being displaced by the Powell Boulevard Phase II Project are in need of relocation assistance over and above that provided under federal law by the Oregon Department of Transportation.
- The Council has directed the Bureau of Economic Development to prepare and execute a special business assistance program for in-City businesses displaced by the Powell Boulevard Phase II Project to supplement assistance provided by the Oregon Department of Transportation.
- 4. The Council has further directed the allocation of Housing and Community Development funds to support this special business assistance program.

NOW, THEREFORE, the Council directs:

a. The FY 1979-80 City budget is hereby amended to transfer appropriations as follows:
