ORDINANCE No. 149544

An Ordinance transferring \$17,174 within the General Fund from General Operating Contingencies to the Bureau of Parks for support of the low-limbing for Public Works Operations and for immediate implementation of the low-limbing program, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Bureau of Parks requires \$17,174 additional within its budget for support of the low-limbing program and crew and implement the City-wide low-limbing operation.
- 2. Operations need to be implemented immediately due to the scheduled work being impeded due to low hanging branches along City streets, so that the paving street sweepers operations function effectively.
- 3. The additional appropriation should be provided by transfer within the General Fund from Operating Contingencies.

NOW, THEREFORE, the Council directs:

a. \$17,174 is transferred within the General Fund from General Operating Contingencies, to the Bureau of Parks, Street Trees, RU 134 as follows:
