ORDINANCE No. 149546

An Ordinance authorizing the donation of certain surplus property to the Jefferson County Search and Rescue for their emergency services program, notwithstanding provisions of Section 5.36.010 of the Code of the City of Portland, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Regulations of the Federal Communication Commission (Part 95.641 1. of Volume VI - Citizens' Band Radio Service) prohibit all sales on or after January 1, 1978, of 23-channel C. B. radios.
- The City's Property Control Warehouse currently has on hand 2. four (4) such C.B. radios, which have been turned in as surplus City property for disposal.
- The Jefferson County Search and Rescue have recently requested 3. by letter the consideration of such radios as a donation to their program.
- Since Federal regulations now prohibit the sale, but not the use, 4. of such C. B. radios, these items are appropriate for donation to the Jefferson County Search and Rescue program.

NOW, THEREFORE, the Council directs:

- The Purchasing Agent is hereby authorized to donate four (4) a. 23-Channel C. B. Radios from City surplus property to the Jefferson County Search and Rescue Program, notwithstanding the provisions of Section 5.36.010 of the City Code.
- Section 2. The Council declares that an emergency exists in order that there may be no delay in providing authority for the donation mentioned in Section 1 hereof; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
