ORDINANCE No. 149549

An Ordinance transferring \$77,859.99 within the Exposition-Recreation Commission Budget for the Civic Stadium for the fiscal year ending June 30, 1980, from General Operating Contingency to Equipment, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. A budget transfer is necessary to cover Exposition-Recreation Commission expenditures for a lease to finance the purchase and installation of the artificial turf at the Civic Stadium.
- By Resolution passed on April 23, 1980, the Exposition-Recreation Commission authorized the transfer of \$77,859.99 within the Civic Stadium Budget for the fiscal year ending June 30, 1980 from General Operating Contingency to Equipment.
- 3. There are adequate funds in the General Operating Contingency to cover this transfer and expenditure.

NOW, THEREFORE, the Council directs:

a. That \$77,859.99 is transferred within the Exposition-Recreation Commission Budget for the Civic Stadium for the fiscal year ending June 30, 1980 from BUC 19910008, Object Code 710, General Operating Contingency to BUC 19800016, Expenditure Code 640, Equipment.

Section 2. The Council declares:

That an emergency exists because the appropriation is needed immediately in the account to which it is to be transferred so there will be no delay in the financing of the artificial turf; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
