An Ordinance amending Contract No. 13819 with Loomis Armored Car Service, Inc., to extend the contract through June 30, 1981, increasing monthly payments to \$194.91, authorizing the drawing and delivery of warrants, providing for acceptance of ordinance by contractor and by Surety, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Water Bureau has entered into Contract No. 13819 with Loomis Armored Car Service, Inc., a Nevada corporation, for furnishing pickup and delivery service of deposits from the Water Service Building, 1800 S.W. Sixth Avenue, to designated banks.
- 2. Loomis Armored Car Service, Inc., finds it necessary to increase its monthly charge for this service.
- 3. The Administrator of the Water Bureau has recommended extension of said contract No. 13819 through June 30, 1981, with an increase in monthly charges to \$194.91.

NOW, THEREFORE, the Council directs:

- a. Contract No. 13819 with Loomis Armored Car Service, Inc., hereby is extended through June 30, 1981 with monthly charges to the Water Bureau in the sum of \$194.91 and with all other terms and provisions of said contract to remain in full force and effect.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants pursuant to the terms of the contract to be charged to the Bureau of Water Works, Water Fund, BUC No. 183000010, Project 1503, Object 260, 1980-81 budget when demand is presented, approved by the proper authorities.
- c. This ordinance shall be an effective extension and amendment of contract No. 13819 as set forth in Section 1 hereof upon written acceptance of this ordinance by Loomis Armored Car Service., Inc., and by Surety on said company's performance bond, and with evidence of insurance coverage as provided in said contract.

Section 2. The Council declares that an emergency exists because a delay in extending the contract may result in additional expense and may unnecessarily deprive the City of the benefits of the contract; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
