

ORDINANCE No. 149568

An Ordinance authorizing the Purchasing Manager to call for bids to furnish all materials, equipment and labor to reconstruct the sewer in S. E. 36th Avenue from S. E. Lambert Street to S. E. Nehalem Street for the Bureau of Sanitary Engineering, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Sanitary Engineering requires the furnishing of all materials, equipment and labor for reconstruction of the sewer in S. E. 36th Avenue from S. E. Lambert Street to S. E. Nehalem Street in accordance with the plans and specifications filed with the Purchasing Division.

NOW, THEREFORE, the Council directs:


- a. The Purchasing Manager shall advertise for bids using plans and specifications filed in his office.
- b. The Public Works Commissioner and the Auditor are authorized to execute a contract with the most favorable bidder as designated by the Council.
- c. The Mayor and the Auditor are authorized to draw and deliver warrants chargeable to the Sewage Disposal Fund, FY 1979-80 Budget, Bureau of Sanitary Engineering, Design Engineering Division, RU 146, Object Code 630, Improvements, when demand is presented and approved by proper authority.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
