An Ordinance accepting a street deed for right-of-way required for the improvement of S.E. 84th Avenue between S.E. Lafayette Street and S.E. Powell Blvd. granted by Union Labor Retirement Association and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Right of way is required for the improvement of S.E. 84th Avenue between S.E. Lafayette Street and S.E. Powell Blvd. Street Improvement Project.
- 2. Union Labor Retirement Association has conveyed the required right of way to the City at no cost.
- 3. The Planning Commission has approved the street dedication request.
- NOW, THEREFORE, the Council directs:
 - a. The following described tract is hereby accepted for street purposes:

A parcel of land lying in the southwest quarter of Section 9, TIS, R2E, W.M., Multnomah County, Oregon, described as follows:

Beginning at the southwest corner of that tract of land conveyed to Union Labor Retirement Association by deed recorded September 7, 1979, in Book 1380 at Page 2285, Multhomah County Deed Records; thence northerly along the west line of said tract 5.0 feet; thence southeasterly 7.07 feet, more or less, to a point in the south line of said tract being 5.0 feet east of the southwest corner thereof; thence westerly along the south line of said tract 5.0 feet to the point of beginning.

b. The Auditor shall record in appropriate deed records, documents of title as necessary for acquitition of this right of way.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the street deed might jeopardize the City's ability to acquire the property at no cost; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
