ORDINANCE NO. 149571

An Ordinance accepting four easements for the SW Arnold Creek sanitary sewer project, granted by Henry E. Baldridge and Dale Construction Co., Martha Roemer, and Leonard A. Wynkoop, authorizing total payment of \$1,723.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Right-of-way is required for construction of the SW Arnold Creek sanitary sewer project.
- 2. Henry E. Baldridge and Dale Construction Co., Martha Roemer. and Leonard A. Wynkoop have conveyed the required right-of-way to the City for the total sum of \$1,723.00.

NOW, THEREFORE, the Council directs:

a. That the following described easements are hereby accepted for sewer purposes:

The west 15.0 feet of the following described tract of land to wit:

That portion of the northeast quarter of the northeast quarter (NE¼ NE¼) of Section 32, T1S, R1E, Multnomah County, Oregon, lying north of SW Arnold Street.

In addition to the above described perpetual easement, a temporary easement for the original construction of said sewer line over a strip of land 7.50 feet, east of and adjacent to the above described perpetual easement. (Granted by Dale Construction Company and Henry E. Baldridge.)

A portion of Lot 3, Galeburn Place, Multnomah County, Oregon, being a strip of land 15.0 feet in width, 7.50 feet on each side of the following described centerline:

Beginning at a point on the north line of a tract of land conveyed to Martha Roemer by deed recorded November 25, 1969, in Book 708, page 1330, Multnomah County deed records, which bears N.00⁰39'E., 100.0 feet and S.89⁰39'E., 247.26 feet from the southwest corner of Lot 4, Galeburn Place; thence S.00⁰39'W., 100.0 feet to the south line of said Roemer tract and there terminating. In addition to the above described perpetual easement, there is also granted a temporary easement for the original construction of the sewer described as follows:

A strip of land 10.0 feet in width, adjacent to and on each side of the above described perpetual easement. (Granted by Martha Roemer.)

The west 15.0 feet of the north 62.60 feet of the south 262.60 feet of Lot 1, Arrowood, Multnomah County, Oregon.

In addition to the above described perpetual easement there is hereby granted a temporary easement 7.5 feet in width and lying north of and adjacent and east of and adjacent to the above described perpetual easement. (Granted by Leonard A. Wynkoop.)

b. The Mayor and Auditor to draw and deliver warrants in payment for the above described easements in the amounts and in favor of the following:

c. The Auditor shall record in the appropriate deed records, documents of title as necessary for purchase of this right-ofway.

ORDINANCE No.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the sewer easements might result in delays in construction of the sewer; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
