ORDINANCE NO. 149577

An Ordinance amending Ordinance No. 149088, which provided for the abatement of a public nuisance located at 1033 N.E. Beech Street, by extending the time for abatement and removal in consideration for a repair permit obtained by the owner of the property and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 149088 declared the building located at 1033 N.E. Beech Street more particularly described as E. 50' of Lot 8, Block 7, Lincoln Park in the City of Portland, Multnomah County, Oregon, to be a public nuisance and provided for a ten (10) day period after the effective date of said ordinance for abatement of said nuisance. That subsequent to the passage of Ordinance No. 149088, the owner of said property has obtained a building permit to repair the dwelling. That such repairs cannot be completed within the time specified for the abatement of the nuisance by Ordinance 149088.
- 2. The owner of the above referenced property has submitted an agreement to complete the repairs within sixty (60) days or abate the nuisance by removal in consideration for an extension of time.
- 3. The Bureau of Buildings recommends and the Commissioner in charge approves the request be granted.

NOW, THEREFORE, The Council directs:

- a. Ordinance No. 149088 is hereby amended by extending the time for abatement of the nuisance for an additional sixty (60) days in order to allow the owner to complete the repair work within such time as is provided for under building permit as issued, and in the event that the above is not accomplished, abatement procedures shall become effective immediately upon the expiration of the above time extension.
- b. In consideration for the above time extension the owner of the property has provided the City with an agreement which is marked Exhibit "A" and attached to the original only hereof.

ABATEMENT OF PUBLIC NUISANCE AGREEMENT

For the consideration of the extension of time for abatement of a nuisance located at 1033 N.E. Beech Street as described in Ordinance No. 149088 passed by the City Council of the City of Portland on January 31, 1980, the undersigned hereby agrees to complete the repairs within sixty (60) days of the date of the permit or abate the nuisance by removal.

The undersigned further agrees that in the event the abatement is not completed within the time specified herein, the Director of the Bureau of Buildings shall abate the same by hiring a private contractor to demolish the building.

THE UNDERSIGNED, HAVING READ THE FOREGOING AGREEMENT, understands that no other consideration will be given and that this contains the entire agreement between the parties hereto and that there is no other agreement, promise or inducement other than as expressed by this agreement.

That an emergency exists because delay in the enactment of this ordinance could result in unnecessary action by the Director of the Bureau of Buildings in abatement of the nuisance within the time specified in the original ordinance; therefore, this ordinance shall be in force and effect, from and after its passage by the Council.
