

ORDINANCE No. 149581

An Ordinance amending Section 5.52.010 of the City Code to create a change cash account of \$100.00 for the St. Johns Racquet Center, providing for acceptance of ordinance, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The new indoor racquet sports facility, operated by the Bureau of Parks is scheduled to open May 5, 1980; that no cash fund exists at the new facility; that it is necessary that \$100.00 be established at the indoor racquet sports facility to take care of the daily cash needs for making change at the facility and that the Superintendent of the Bureau of Parks has recommended and the Commissioner-in-Charge thereof has approved such creation of a change cash account.

NOW, THEREFORE, the Council directs:

- a. Section 5.50.010 of the City Code hereby is amended to read as follows:

Tennis Fund (Park Bureau)


St. Johns Racquet Center, Change Cash \$100.00

- b. The Mayor and the Auditor hereby are directed to draw and deliver a warrant to be charged to the Tennis Fund, St. Johns Racquet Center, BUC #60200149, Object Code 380.


Section 2. The Council declares that an emergency exists in order that there may be no unnecessary delay in establishing the change cash account for the St. Johns Racquet Center; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
