An Ordinance amending Ordinance No. 148812, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended September 30, 1979, by cancelling the assessment against Marengo Addition, Block 4, Lots 5 and 6 and reducing the total assessment by \$333.90 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Ordinance No. 148812 assessed Marengo Addition, Block 4, Lots 5 and6 \$333.90 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended September 30, 1979, and entered in the City Lien Docket Book 124, Page 116.
- The Neighborhood Quality Division of the Bureau of Buildings has recommended this assessment be cancelled because the property owner was qualified for a waiver of fees.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 148812, is amended by cancelling the assessment against Marengo Addition, Block 4, Lots 5 and 6, and reducing the total assessment of \$12,959.93 to \$12,626.03.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
