ORDINANCE No. 149588

An Ordinance authorizing waiver of certain building permit fees for the erection of a tent in connection with the Lewis and Clark College Renaissance Fair, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That Lewis and Clark College intends to sponsor its annual Renaissance Fair from May 16, 1980 to and including May 18, 1980;
- 2. That Michael Ford, Director of Campus Programs, Lewis and Clark College, 0615 S. W. Palatine Hill Road, Portland, Oregon 97219, on behalf of said College has indicated that the College intends to erect a tent in connection with said Renaissance Fair, and requests that the \$150 fee for the permit to erect a tent as required by Section 24.03.030 of the City Code be waived.
- 3. That said request has been approved by the Bureaus of Fire and Buildings and the Commissioners in charge and should be granted.

NOW, THEREFORE, The Council directs:

a. The building permit fee as required by Section 24.03.030 of the Code of the City of Portland, Oregon for the erection of a tent in connection with the Lewis and Clark College Renaissance Fair to be held from May 16, 1980 through May 18, 1980 is hereby waived, but this shall not constitute a waiver of any other provisions of the Code of the City of Portland, Oregon.

Section 2. The Council declares that an emergency exists so that the construction of the tent described in Section 1 hereof may be made without undue delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
