# ORDINANCE NO. 149614

An Ordinance amending a contract between the City of Portland and Compass Management Group, Inc., to provide professional services for an Emergency Medical Services management information system for the Bureau of Emergency Communications, to extend the date of the contract to December 31, 1980, at no additional cost, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The City of Portland has authorized a contract for a management information system for the Emergency Medical Central Dispatch system to be installed at Kelly Butte, Ordinance No. 148356, August 16, 1979.
- 2. The terms of the contract have expired and due to unanticipated delays in installing the system, the contractor's work has not been completed.
- 3. An extension of the contract through the projected installation date of the new system will enable the necessary support to ensure an uninterrupted work flow on the management information component.
- 4. Funds were appropriated by Ordinance No. 148206 on August 1, 1979, for the purpose of letting the contract, and no additional expenditures are required for the extension.

NOW, THEREFORE, the Council directs:

- a. This ordinance shall be an effective extension and amendment of Contract No. 18177 as set forth in Section 1, to December 31, 1980, hereof upon written acceptance of this ordinance by Compass Management Group, Inc., 4522 S.W. Water Avenue, Suite 109, Portland, Oregon, 97201.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants pursuant to the terms of the contract, chargeable to the Bureau of Emergency Communications when demand is presented, approved by the proper authorities.

### **ORDINANCE** No.

Section 2. In order that efficient dispatching services be provided to the citizens of Portland for Emergency Medical Services, it is necessary to complete this project expeditiously; therefore, an emergency hereby is declared and this Ordinance shall be in force and effect from and after its passage by the Council.
