

ORDINANCE No. 149794

An Ordinance revising salary rates in the Compensation Plan for Pittock Mansion Director, Bureau of Parks, effective May 21, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. At the request of the Commissioner-in-Charge of the Bureau of Parks, the Bureau of Personnel has conducted a review of salary rates for Pittock Mansion Director.
2. On the basis of the review findings, the Bureau of Personnel has recommended a new salary range for the classification.
3. The changes should be effective May 21, 1980.

NOW, THEREFORE, the Council directs:


Hourly salary rates in the Compensation Plan for the position of Pittock Mansion Director are hereby revised as follows, effective May 21, 1980:

Position Job Class Number	Entry Rate	After 1 yr.	After 2 yrs.	After 3 yrs.
4340	\$8.86	\$9.42	\$9.67	\$9.96

Section 2. The Council declares that an emergency exists; in order that there may be no unnecessary delay in revising the salary rates as outlined in Section 1 hereof; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
