

ORDINANCE NO. **149811**

An Ordinance amending the FY 79/80 City Budget by transferring appropriations between budget categories and various line items within the Human Resources Bureau, AU 380, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Pursuant to Ordinances numbered 147960, 148272, 149610, 149648, and 149650, certain appropriations were allocated to the Human Resources Bureau, AU 380, for FY 79/80.
2. Based on a final review of the Bureau's budget, it has been determined that budget categories and various line items need to be adjusted.
3. It is, therefore, appropriate to amend the FY 79/80 City Budget by transferring appropriations between budget categories and various line items.

NOW, THEREFORE, the Council directs:

- a. The FY 79/80 City Budget is hereby amended by transferring appropriations between budget categories and the various line items within the Human Resources Bureau, AU 380, as follows:
