An Ordinance amending the FY 79/80 City Budget by transferring appropriations between budget categories and various line items within the Human Resources Bureau, AU 380, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to Ordinances numbered 147960, 148272, 149610, 149648, and 149650, certain appropriations were allocated to the Human Resources Bureau, AU 380, for FY 79/80.
