ORDINANCE No. 149836

An Ordinance transferring \$28,233 within the Water Fund to cover extraordinary overtime expenditures, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Water Works has been requested by the Department of Public Works to assist in washing volcanic ash from City streets and will include the last two week-ends of the current fiscal year.
- 2. The Bureau of Water Works has responded to these requests with a significant portion of the work performed on overtime status at an overtime cost of \$13,233.
- 3. The two week-ends of work which are requested will involve overtime status at an anticipated cost of \$15,000.
- 4. The above described overtime work was unrelated to the operation and maintenance of the water system and not anticipated in the preparation of the 1979-80 budget.
- 5. The above described overtime work is a direct result of the Mt. St. Helens eruption of June 12, 1980.
- 6. As overtime is a controlled line item, the transfer is necessary to ensure that an over-expenditure does not occur.
- The Bureau of Water Works is in need of additional overtime appropriations and the Commissioner-in-Charge recommends a transfer of \$28,233 from Water Fund Contingencies.

NOW, THEREFORE, the Council directs:

- a. A transfer of appropriation in the amount of \$28,233 be made within the Water Fund (number 05) from Contingencies, BUC 17400155, Object 710, to Construction and Maintenance, Field Support Overtime, BUC 18400081, Project 0184, Object 140.
- Section 2. The Council declares an emergency exists in order that the necessary appropriation transfer may be made without undue delay; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
