ORDINANCE No. 149844

An Ordinance transferring \$5,000 within the General Fund from RU 620, Full-Time Employees, Object Code Number 110, to RU 620, Overtime, Object Code Number 140, for the purpose of increasing the Bureau of Emergency Communications' budget appropriation for overtime expenditures, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Emergency Communications requires \$5,000 additional within its budget for Overtime.
- 2. The Bureau of Emergency Communications requires an increase in its budget appropriation for Overtime in order to maintain the operational effectiveness of its emergency call-taking and police dispatch functions during the remainder of the 1979-80 fiscal year.
- 3. This additional appropriation for overtime is required in order to cover unexpectedly high expenditures necessitated by the recent Mount St. Helen's ash fallouts and Rose Festival activities and to provide funds to satisfy any additional overtime requirements which may be caused by renewed volcanic activity.
- 4. The additional appropriation should be provided by transfer within the Bureau of Emergency Communications' budget.

NOW, THEREFORE, the Council directs:

- A. \$5,000 is transferred within the General Fund from RU 620, Full-Time Employees, Object Code Number 110, to RU 620, Overtime, Object Code Number 140.
- Section 2. The Council declares an emergency exists, because the appropriation is needed immediately in the account to which it is to be transferred so that there may be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
