

ORDINANCE No. 149879

An Ordinance amending the FY 79/80 City Budget by increasing appropriations in the amount of \$100,000 to the Human Resources Bureau, Training and Employment Division, AU 652, to implement the Summer Youth Employment Program for the period June 16, 1980 through June 30, 1980 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That although a formal notice of grant award has not been received, the Department of Labor has allocated to Portland \$1,462,932 for the program.
2. During the interim, the Training and Employment Division requires \$100,000 to operate the program from June 16, 1980 through June 30, 1980.
3. The Notice of Grant Award from the Department of Labor is anticipated within the next forty-five days.
4. It is therefore appropriate that the 79/80 City Budget be amended by increasing appropriations in the amount of \$100,000 to the Human Resources Bureau, Training and Employment Division AU 652, for the period June 16, 1980 through June 30, 1980.

NOW, THEREFORE, the Council directs:

- a. The Finance Officer is hereby authorized to amend the 79/80 City Budget by increasing appropriations in the amount of \$100,000 in the following manner:
