ORDINANCE NO. 149935

An Ordinance transferring appropriations in the amount of \$52,801 within the General Fund from the Bureau of Police, Records Division, to Operating Contingency, Unforeseen Reimburseable Expenditures, abolishing three positions of Police Records Clerk I and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That at the time of the preparation of the Police Bureau's FY 80-81 budget, responsibilities of its Records Division included tow dispatching.
- 2. That accordingly, resources for the performance of the above services were requested and approved in the Bureau's budget for FY 80-81.
- 3. That it has been decided since the budget was approved, that the tow dispatching functions would continue to be contracted to a private company.
- 4. That it is, therefore, necessary to transfer the unneeded appropriations to Operating Contingency, Unforeseen Reimburseable Expenditures, and to abolish three (3) positions of Police Records Clerk I.

NOW, THEREFORE, the Council directs:
