

# ORDINANCE No. 156738

An Ordinance repealing existing Title 31, Fire Regulations, and substituting, therefore, a revised Title 31, Fire Regulations, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Regulatory Review Committee Report to Council recommends that the city's construction codes be revised for clarity and consistency.
2. For the purpose of exempting the City of Portland from regulation by the State Fire Marshal, Title 31 has been revised to provide a more complete enabling document, to be submitted to the State Fire Marshal for his review and approval.
3. In the interests of promoting economic development within the city, Title 31 has been revised to be consistent with the Fire Prevention Code adopted statewide on August 18, 1983.

NOW, THEREFORE, the Council directs:

- a. That Title 31, Fire Regulations of the City of Portland, is hereby repealed and a new Title 31, Fire Regulations, is hereby enacted to read as attached.

Section 2. The Council declares that an emergency exists in order to provide for the protection of the general public, and therefore this ordinance shall be in force and effect from and after its passage by the Council.


