An Ordinance authorizing the Human Resources Bureau, Training and Employment Division, to accept a Department of Labor, CETA Title IID Discretionary Grant in the amount of \$152,467; appropriating such funds into the Division FY80-81 budget, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That the Department of Labor has made CETA Title IID Discretionary funds in the amount of \$152,467 available to the Training and Employment Division.
- 2. The funding is for the purpose of assisting the City's Mt. St. Helens eruption ash clean-up efforts.
- There is no match required of the City for this grant.
