An Ordinance accepting a portion of Lot 10, Block 8, Taborside, deeded by Patricia J. Wilson, a widow, for the widening of S.E. Market Street, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described parcel of property be and is hereby accepted for street purposes:

A portion of Lot 10, Block 8, Taborside, more particularly described as follows:

Beginning at the southeast corner of Lot 10, Block 8, Taborside; thence westerly to the southwest corner of said Lot 10; thence northerly along the west line of said Lot 10, a distance of 20 feet to a point; thence southeasterly to the point of beginning, all within the corporate limits of the City of Portland, County of Multnomah and State of Oregon. (Deeded by Patricia J. Wilson, 7606 S.E. Clay Street.)

Section 2. That the City Auditor be and he is hereby directed to have the deed for street purposes as described in Section 1 of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in the widening of this street; therefore an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
