#### 150110 ORDINANCE N O.

An Ordinance amending Ordinance No. 149826 which adopted the annual budget of the City of Portland for the fiscal year beginning July 1, 1980, by adding Section 4.A., indicating total dollar appropriations for each line item of Personal Services, and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. Ordinance No. 149826 adopted the City's annual budget for the fiscal year beginning July 1, 1980. Total appropriations for Personal Services is shown as \$109,327,744.
- Ordinance No. 150009 has authorized the employment of Wilbur L. Jurden, Jr., Consultant, to assist the City in developing a plan for Social Security sick pay exclusion.
- In connection with the development of this program, it is now necessary to provide the specific dollar appropriation for sick pay as authorized in Section 4.28.080 of the City Code. For our purposes we have estimated sick pay to be 3% of gross wages on an annual basis.
- 4. It is appropriate that this information be made a part of the City's 1980-81 formally adopted budget.
- This amendment does not affect the total appropriations for Personal Services for FY 1980-81.

#### NOW, THEREFORE, the Council directs:

Ordinance No. 149826 is hereby amended by the inclusion of Section 4.A., which indicates specific dollar appropriations for all Personal Services line items, as follows:

"Section 4.A. Funds for Personal Services are appropriated separately for the following purposes:
