ORDINANCE NO. 150115

An Ordinance creating ten (10) part-time temporary positions of petition checker in the Office of City Auditor, beginning August 1, 1980, fixing the rates of pay, making a transfer of appropriation within the General Fund from General Operating Contingencies to the Office of City Auditor, Personal Services in the amount of \$1,800.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City Auditor has requested authorization for ten (10) parttime temporary positions of petition checker at \$3.75 per hour.
- 2. The positions are necessary to check signatures on initiative petitions that have been filed with the City Auditor for elimination of mandatory weatherization of buildings requires vote.
- 3. The petition verification must proceed in accordance with the wishes of the petitioners in order for proponents and opponents to start their campaign.
- 4. The rates of pay for these positions are comparable with those paid by Multnomah County for such duties and that the checking required the use of records of the Multnomah County Registrar of Elections and that the positions and rates of pay should be authorized in accordance with the Auditor's request.

NOW, THEREFORE, the Council directs:

a. Ten (10) part-time temporary positions of petition checker at \$3.75 per hour are hereby created in the Office of City Auditor.

Section 2. The Council further directs:

a. In order to make funds available for the positions created in Section 1 above, appropriation in the amount of \$1,800.00 is hereby transferred within the General Fund from General Operating Contingencies (20100010) to the Office of City Auditor RU #336, Personal Services, Object Code 120 (\$1,500.00), Object Code #170 (\$300.00).

Section 3. The Council declares that an emergency exists because the positions to be created are immediately required so that petitions may be checked without delay; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
