Section 1. The Council finds:

- 1. Right of way is required for construction of the SW Arnold Creek Sanitary Sewer Project.
- William H. Hardt and Katherine D. Hardt, David A. Stich and Georgia A. Stich, Frank P. Monaco and Evelyn Margueritte Monaco have conveyed the required right of way to the City for the total sum of \$214.00.

NOW, THEREFORE, the Council directs:
