

# ORDINANCE No. 150198

An Ordinance amending Ordinance No. 149664, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended March 31, 1980, by reducing the assessment for Block 44, Lot 13, Westmoreland by \$43.06 and reducing the total assessment from \$5,180.95 to \$5,137.89, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 149664 assessed Block 44, Lot 13, Westmoreland, \$473.66 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended March 31, 1980, and entered in City Lien Docket Book 124, Page 223.
2. \$430.60 of this amount was for the actual work done. \$43.06 was added as a 10% assessment fee. Delays in mail delivery made it impossible for property owner to pay before the allotted time to avoid the 10% charge. Therefore, the lien against subject property should be reduced from \$473.66 to \$430.60

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149664 is amended by reducing the assessment against Block 44, Lot 13, Westmoreland, by \$43.06 and reducing the total assessment of \$5,180.95 to \$5,137.89.

Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
